

NOTES TO THE FINANCIAL STATEMENTS (Unaudited)

FOR THE YEAR ENDED DECEMBER 31, 2022

1. Description of the Organization

The Church of Jesus Christ of Latter-day Saints in Canada (the "Church) was incorporated in 2014 by the Church of Jesus Christ of Latter-day Saints in Canada Act of the Legislative Assembly of Alberta. The Church is a registered charity classified as a charitable organization under the Income Tax Act (Canada).

2. Notes Receivable from Subsidiary

Notes receivable are from a controlled organization bearing interest from 3.95% to 7.25% and at 1.5% per annum with repayment terms outlined in the respective agreements. During the year, the Church reported interest income of \$1,467 on the notes.

3. Investment in Subsidiary

The Church owns 100% of the shares of a private, for-profit company and accounts for the investment using the cost method. The estimated fair value of the company is \$357,700 as of December 31, 2022.

4. Amounts Due to Related Party

The related party is an organization under common control, and the amount due relates to goods and services acquired from the related party. These transactions were in the ordinary course of operations and have been recorded at the exchange amount, which is the amount of consideration established and agreed to by the related parties.
